Subject: Standard RFP document for selection of Authority's Engineer for works to be implemented on Engineering Procurement and Construction (EPC) mode-Reg.

Madan /Sir,

Ministry vide letter of even number dated 16th September, 2013 has circulated Standard RFP document for selection of Authority's Engineer for works to be implemented on Engineering Procurement and Construction (EPC) mode. Certain modifications were made in the Standard RFP document vide letter of even number dated 11th December, 2014 and 16th Nov,

- The existing document has no provision for deployment/ induction of design specialist as key personnel in the RFP. Now, it has been decided to provide for input say 3 to 4 months of (i) Highway Design Specialist and (ii) Bridge Design Specialist in the RFP document so that the CVs for the same and rates for their input may be provided by the consulting firm in the financial bid. Their CVs shall be included in the technical evaluation.
- The appointment of umbrella State-wise Authority Engineer by Ministry shall be discontinued with effect from 1st January, 2016. Henceforth, project wise appointment of Authority Engineer shall be carried out by State PWDs for projects costing up to Rs 300 crores. For projects costing more than Rs 300 crores, Ministry will continue to appoint Authority
