This is in continuation to Ministry's circulars referred above.

2. In view of maintaining uniformity in interpretation during bid evaluation in respect of 'Highway Sector' works for assessing the 'similar work experience' of bidders as per Clause 2.2.2.2 of the RFP, the Clause 2.2.2.2 & 2.2.2.5 shall be amended as under:-
