



Subject:- Implementation of order dated 25-02-2010 of the Hon'ble AFT(PB), New Delhi in TA No. 87 of 2009 titled Col. GLN Keshav and others Vs UoI regarding grant of Compensatory Field Area Allowance (CFAA) and Compensatory Modified Field Area Allowance(CMFAA)- Extension of benefits of Hon'ble AFT Order to all similarly placed Army officers/PBORs.

2. The matter has been examined in consultation with Defence (Finance)/MoF. MoF vide their ID No.9(17)/2014-E.II(B) dated 01.10.2015 (copy enclosed) has agreed to extend the benefit for grant of CFAA/CMFAA to the similarly placed Army officers & PBORs (non-applicants) posted in various projects of BRO, in accordance with the order dated 25-2-2010 of AFT, New Delhi, provided such officers and PBORs otherwise fulfil the eligibility conditions for grant of CFAA and CFAA is admissible to them as per terms and conditions of MoD letter dated 13.1.1994 and that the same was being denied to them by invoking of DGBR Administrative instructions dated 13.4.1994.


