Subject: Enhancement of leave in respect of members of General Reserve Engineer Force (GREF)

Sir,

I am directed to convey the sanction of the President of India to enhance Earned Leave from 30 days to 60 days and Casual Leave from 12 days to 15 days to the members of General Reserve Engineer Force in a calendar year, serving in the units/establishments of BRO which work on 06 days week basis.

- 2. The leave account of such members shall be credited with earned leave in advance in two instalments of 30 days each on the 1st of Januar, and the 1st of July every year subject to the following conditions namely:-
 - (a) the leave at credit of such member at the close of the previous half-year shall be carried forward to the next half-year, subject to the condition that the leave so carried forward plus the credit for the half-year does not exceed the maximum limit as specified in Central Civil Services (Leave) Rules, 1972, which is 300 days at present.
 - (b) earned leave shall be credited to the leave account of a member of the force or enrolled person at the rate of 5 days of each completed calendar month of service which he is likely to render in a half year of the calendar year in which he is appointed or is transferred from where unit/establishment work 06 days week basis.
 - (c) the credit for the half year in which such member is due to retire or resigns from the service or is transferred from where unit/establishment work 06 days week basis to where unit/establishment work 05 days week basis shall be afforded only at the rate of 5 days per completed calendar month up to the date of retirement, resignation or transfer as the case may be,
 - (d) When such member, working in a unit/establishment on 06 days week basis, is removed or dismissed from service or dies while in service, credit of earned leave shall be allowed at the rate of 5 days per completed calendar month up to the end of calendar month preceding the calendar month from which he is removed or dismissed from the service or dies in service.
 - (e) while affording credit of earned leave, fractions of a day shall be rounded off to the nearest day,
