2. The stay of the indl posted on permanent posting to his/their new units should be allowed to complete at least six months to meet audit requirement.
3. Please also ensure no disciplinary/Vigilance cases against indl pending or he is not involved in such cases. A certificate to this effect be attached invariably with the movement order of the indl while dispatching him to BCA/MCA. In case any indl is involved in such cases, GREF Records should be informed immediately and move of indl be withheld till clearance from this office.
4. Please ensure that an option/undertaking be obtained duly exercised prior to move by the concerned indl in accordance with para 5 (b) (iii) of chapter 19 of ROI-1998 wherever transfer incidentals are not admissible due to non completion of 6 months tenure in present unit. **If the move is not implemented as per the given time line/without prior concurrence, such posting shall automatically stands cancelled.**
5. All CEs/CDRs/OCs are requested to ensure that there is no adverse spoken reputation against indls before dispatching to foreign assignment. In case, there is any adverse spoken reputation, then move of the indl is to be withheld by CE/CDR/OC concerned and intimation to this effect be given in writing to GREF Records under information to HQ DGBR/EG2 (Pos) immediately for further action. In this connection also refer to amendment Srl No. 31 made as sub para 5 (j) of Chapter 19 of ROI 1/1998.
6. Detailed instructions are attd as per appx for strict compliance please.

1. The dispatching unit will ensure that the individual(s) meets the following conditions before despatch to the new unit in terms of HQ DGBR letter No 13001/POL/POS/EIA dt 24 Feb 98, 12520/PP/DGBR/EG2 dt 27 Feb 2000, 12520/PP/DGBR/EG2 dt 02 Mar 2001, 12520/PP/DGBR/EG2 dt 22 Jun 2001, 12520/BCA/P/DGBR/299/EG2 dt 28 Mar 2008 and amendment in chapter 19 of ROI 1/98 circulated vide GREF Records letter No. 0047/164/AR1 dated 12 Dec 2008 :-
  - (a) Individual must be Medical Category GREF-I. However Pers selected must be medically examined and fitness certificate issued by the RMO/DADMS regarding their medical fitness be attached with the movement order as per instructions issued by Dte vide their letter No. 12508/DTK/DGBR/137/EG2 dt 20 Aug 2007.
  - (b) Has not been awarded any major punishment during his entire service and no minor punishment during last 10 yrs.
  - (c) An individual should have earned a minimum of four "Very Good" and one "Good" ACR grading in the last five years of service. In case of indl promoted from Group 'D' Posts (where No ACR is initiated) to another higher grade (where ACR is initiated) and have earned less than five ACRs on the date of consideration, he must have the following grading :-
    - (i) If earned 4 ACRs - Minimum three Very Good & one Good
    - (ii) If earned 3 ACRs - Minimum two Very Good & one Good
    - (iii) If earned less than three ACRs as mentioned in (i) above he will not be considered for BCA/MCA posting.
  - (iv) Average grading in any ACR during last ten years is a disqualification/debarring factor for selection.
  - (d) No Vigilance/disciplinary case is pending against him/them.
  - (e) Has not done a foreign tenure for more than six months ever during entire service.
  - (f) Has not availed compassionate posting and deputation during the preceding 10 years.
  - (g) Has not availed deputation abroad.
  - (h) Has served 22 months physically service who have been TORs in HAA before 01 Jan 2009 and 26 months physical service for those who are TORs on or after 01 Jan 2009.
  - (i) In case, where indl has been promoted, ensure that indl assumed the appt/trade shown in the posting order on or before the cut off date.
  - (k) Move will be carried out as noted against his name, falling which his posting order will be considered for cancellation in terms of HQ DGBR signal No 261370/EG2 dated 27 Aug 2001. If indl is/are involved in disciplinary case or any case/disciplinary action is contemplated against him, he will not be moved till finalization of the case and this office will be informed accordingly.
  - (l) In the case where indl has been posted to BCA/MCA in a particular trade, but stands promoted to higher rank, an unconditional unwillingness certificate to accept promotion be obtained before despatch. In case indl refuses to render unconditional unwillingness certificate, the indl may not be dispatched to BCA/MCA and matter referred to this office for cancellation of posting order. **An undertaking certificate as per the format to forgo promotion/anti date seniority att at Annexure-I be obtained from the indl and submitted to GREF Records duly countersigned by an Officer for record.**
  - (m) It will also be ensured that the posted persons to report in BCA/MCA by given date, failing which his posting order will be cancelled in terms of HQ DGBR Sig No 261370/EG2 dt 27 Aug 2001.
  - (n) Ensure that there is no adverse spoken reputation against the individual before dispatching to foreign assignment. In case, there is any adverse spoken reputation, move of the individual is to be with held by CE/Cdr/OC concerned as per sub para 5 (f) of chapter 19 of ROI 1/1998.
  - (o) Any recovery from pay and allowances ordered after Court of Inquiry under Section 160 FR, Section 90 (g) or 91 (g) of AA 1950 will be disqualification barring an individual's entry to BCA/MCA/Any foreign tenure as directed vide HQ DGBR letter No. 12520/PP/DGBR/EG2 dated 14 Feb 2002. Units/Projects are required to ensure before dispatching the indls on permanent posting to BCA/MCA units that no penalty/recovery has ever been imposed on the indls concerned.
  - (p) **The cut off date for consideration of HI is 31 Dec 2016 and ACR grading has been considered upto 31 Dec 2016.**
2. The instructions contained in HQ DGBR letters No 13001/POL/POS/DGBR/EIA dt 24 Feb 1998, 13001/POL/POS/56/DGBR/EG2 dt 11 Feb 2000, 12520/PP/DGBR/EG2 dt 27 Apr 2000 and 12520/PP/DGBR/EG2 dated 02 Mar 2001 have been taken into consideration, while considering the indl for BCA/MCA posting. However, unit concerned are requested to please ensure that the indls being SOS to BCA/MCA units, is/are fulfilling the criteria in all respects as per ibid letters/instructions issued from time to time.
3. A copy of movement order will invariably be endorsed to this office in each case.
4. Reliever wherever required will be provided separately.
