

INCORRECT PUBLICATION OF PART-II ORDERS GRANTING SCRLA/SDA/HAA ALLOWANCES TO NON ENTITLED PERSONNEL

1. Of late it has been noticed by this Dte that various complaints regarding grant of SCRLA/SDA/HAA etc, to non entitled personnel, are lodged by various personnel in BRO units. The matter has been analysed by this Dte in detail and it revealed that certain units are publishing false DOs Part-II in favour of their personnel, even though they are not actually deployed in the designated areas for the allowance. This has been viewed seriously by the authority competent and directs all units to stop such practice immediately.
2. Projects are requested to issue directives in this regard and apply suitable corrective mechanism whenever such lapses come to the notice. Project/TF may conduct workshops to educate their staff about the legitimate allowances applicable in the designated areas under their respective Command and Control. Daily Orders published by the units under AOR, must be got verified at TF/Project level to stop recurrence of such lapses.

DEPLOYMENT OF CPLS AGAINST UNAUTHORISED WORK

1. Further to this Dte letter No.18324/T&C/CPLs/DGBR/140/T&C dated 29 Sep 2015.
2. Despite clear instructions by this Dte, units are still deploying CPLs for unauthorised works which is a clear violation of Departmental Regulations. It is appreciated that, monthly report regarding deployment of CPLs and a certificate to the effect that they are engaged against their authorised works, is submitted to this Dte by Projects every month, but the very purpose of this report is defeated by such unauthorised deployments. This is highly incorrect and needs to be stopped immediately. Any deployment in contravention to regulations needs to be supported with provisions to do so.
3. CE Projects are requested to ensure that CPLs are deployed only for the purpose for which they are mustered and thereby ensuring that the instructions disseminated on deployment of CPLs is adhered in letter and spirit. Delinquent officials may be dealt with severely.
