Ministry vide letter No.RW/NH-37010/4/2010/PIC dated 26th November 2012 and further vide letter dated No. RW/NH-37010/4/2010/PIC dated 01st August 2013 has issued instructions regarding works to be taken on EPC Mode. As per the EPC document, the Authority has to appoint an Authority's Engineer (a consulting engineering firm) within 15 days from the date of agreement.

2. Ministry has prepared a Standard RFP document for selection of 'Authority's Engineer for standalone works to be implemented on EPC Mode. The document is available on Ministry's website www.morth.nic.in. The document shall be followed for selection of Authority's Engineer for various civil construction works on National highways and other centrally sponsored schemes to be implemented on EPC mode.
