## NOTIFICATION

New Delhi, the 24th October, 2003

**G.S.R. 421.**—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Senior Private Secretary of Group 'B' (Gazetted) in the Border Roads Organisation in the Ministry of Road Transport and Highways, namely :—

**1. Short title and commencement.**—(1) These rules may be called the General Reserve Engineer Force (Senior Private Secretary) Recruitment Rules, 2003.

(ii) They shall come into force on the date of their publication in the Official Gazette.

**2. Number of posts, classification and scale of pay.**—The number of the said posts, its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

**3. Method of recruitment, age limit, qualification.**—The method of recruitment to the said post, age limit, qualification and other matters relating thereto shall be as specified in columns (5) to (14) of the said Schedule.

**4. Disqualification.**—No person,—

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

**5. Power to relax.**—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.

**6. Savings.**—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

12. In case of recruitment by promotion or deputation or absorption grades from which promotion or deputation or absorption to be made.	: <b>Promotion :</b> Private Secretary in the pay scale of Rs. 6500-200-10500 with three years regular service in the grade.

**Note:** Where juniors who have completed their qualifying or eligibility service, are being considered for promotion, their seniors would also be considered, provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period, for promotion to the next higher grade along with their juniors, who have already completed such qualifying or eligibility service.
