1. Reference this HQ letter No. 24886/DGBR/E-Tendering/27/E8 dated 04 Apr' 2012.
2. The E-Tendering process shall be implement in following phased manner:-

Phase-I	01 May' 2012 to 30 Sep' 2012	(i) For Tendering action at project HQ and HQ DGBR - Offline as well as online (e-tendering) process (NIT shall be amended as per appx 'A' to note)
		(ii) For Tendering action at Cdr task forces & OC level - Offline tendering (NIT shall be amended as per appx 'B' to note)
Phase-II	01 Oct' 2012 To 31 Dec' 2012	(i) For Tendering action at OC level, Cdr task force, project HQ and HQ DGBR - Offline as well as online (e-tendering) process (NIT shall be amended as per appx 'A' to note)
Phase-III	01 Jan' 2013	(i) For Tendering action at OC level, Cdr task force, project HQ and HQ DGBR - Online (e-tendering) process only (Format of NIT shall be finalized in Nov' 2012 based on experience gained)

3. All projects/TF HQ's are requested to obtain digital signatures of 5-8/3-4 officers of their HQ from nearest NIC. Since tendering action at OC level is generally not being done, OC may request his Cdr task force to detail opening officers having digital signature from his pool if required. All projects will also be advised to intimate their enlisted/working contractors to obtain digital signatures from nearest NIC.


