OFFICE MEMORANDUM

Subject:- Permission to Government servant to work as Arbitrator and accept fee/honorarium therefore.

Training O.M. No. 17011/21/79-Estt(Allowance) dated 29.9.1981 on the above subject and to say that the matter regarding grant of honorarium/fees to Government servant appointed to act as Arbitrator in disputes between the Government of India and private parties or between private parties, has been reviewed in view of the manifold increase in prices thereby justifying the need for upward revision of the rates which had been prescribed as early as in 1981. It has now been decided, in partial modification of the OM No.17011/21/79-Estt.(Allowance) dt. 29th Sept, 1981 that the honorarium may be paid to an Arbitrator to settle the disputes at the rate of Rs.500/-(Rupees five hundred only) per day subject to a maximum of Rs.10,000/-(Rupees Ten thousand only) per case. Accordingly the aforesaid O.M. dated 29.9.1981 shall be modified as under:-

"the honorarium may be paid to him at the rate of Rs.500/- per day or Rs.250/- per half-day subject to a maximum of Rs.10,000/- per case. For this purpose a day means more than two hours continuous work on any date and half-day means work for two hours or less. He shall record a certificate in writing indicating whether he has done a day's work or a half-day's work on a particular day."

- 2. This issues with the concurrence of the Ministry of Finance.
- 3. In so far as persons working in the Indian Audit and Accounts Department are concerned, these orders issue after consultation with the Comptroller and Auditor General of India.
