(a)	Arunachal Pradesh State Information Commission, ItaNagar decision No. APIC-110/2017/91 dated 08 Jun 2017	APIC directed that "APIC does not have jurisdiction for the Central Govt Department within the State and outside".
(b)	J&K Information Commission, Srinagar decision No. SIC/J/A/96/2017/08 vide letter No. SIC/J/A/96/2017/8420-25 dated 14-06-2017.	The Hon'ble Commissioner held that "it therefore, transpires that there is no reason to think that BRTF (BRO) is not an exempted organisation in terms of Section 21 of State Act. The appeal is, therefore, fit to be disposed of with the remarks that the RTI application cannot be processed further for the reason that BRTF (BRO) being part of BRDB is an organisation exempted from the application of RTI law in terms of Schedule attached to Section 24 of the Central RTI Act".
