

PROVISIONAL DEMAND

1. Ref the fwg:-
 - (a) CS Dte letter No 95350/Q/DDGCS dated 16 Feb 2021.
 - (b) CS Dte letter No 95350/Q/DDGCS dated 09 Apr 2021.
 - (c) CS Dte letter No. 95350/Q/DDGCS dated 16 Mar 2022.
2. PD Sys for Grocery was intro in Feb 2021 with the fwg aims:-
 - (a) To ensure that URCs/ beneficiaries get what is demanded/ desired by them and not what is available in the Depots.
 - (b) To prevent sale of unpopular/ undesired items to beneficiaries.
 - (c) To reduce Not Available (NA)/ Temp Not Available(TNA) items.
3. The sys faced multiple challenges in the initial months but it has now stabilised to a great extent. The denials, NA/ TNA qtys have reduced from 35-40% to 10-15%. The current rate of higher denials, despite availability of adequate stocks, is due to cancellation of PDs by some URCs. The stock earmarked against the PD of a particular URC cannot be sold to other URCs. This leads to accumulation of unwanted stocks, blocking of funds, leading to overstocking at CSD Depots in open areas/ uncovered sheds and losses due to damage caused by weather vagaries.
4. In view of the above, the following be instituted forthwith :-
 - (a) PDs must be scrutinised by an officer/ URC management, thoroughly.
 - (b) PDs should be based on actual reqmt of beneficiaries for popular and desired items.
 - (c) Availability of funds must be factored while prep the PD, as only 20% variation from quantity demanded in PD is allowed.
7. It is advised that due diligence be adopted so that demanding URCs are not straddled with unwanted items. Therefore, items incl in PD must be incl in the final demand & picked up in time, only 20% variation in qty is permitted.
