Subject: - Implementation of Govt. decision on the recommendation of VI th CPC-procedure for notification of pension/family pension based on the CCS (Revised Pay) Rules 2008 in respect of Defence Civilian (including DAD, GREF and Cost Guard employees) and their families, **where PPOs based on pre-revised scales have not been issued and the pension became absolute prior to 2-9-2008.**

Reference: - This office Circular No.58 dated 23-09-2009 and circular no.59 dated 24-09-2008.

Reference is invited to this office circulars as mentioned above regarding notification/revision of pensionary awards based on newly deigned Data Sheets viz- Appendix 'E', 'F', 'G', 'H', 'I' & 'J'. The Data Sheet 'E' is required to be used in cases where Govt. servants retire on or after the date of issue of GOI, P&PW OM No. 38/37/08-P&PW (A) i.e. 2-9-2008. Data Sheet Appendix 'I' has been introduced for revision of pension on the basis of revised scale of pay in respect of Govt. servants in whose case commutation became absolute on or after 1-1-2006 but before issue of aforesaid OM (2-9-2008) and PPOs have already been issued in their favour.

However, procedure for completion of Data Sheets based on revised scale of pay in respect of Govt. servants in whose favour PPOs based on pre revised scale of pay **has not been issued and in whose cases commutation of pension became absolute on or after 1-1-2006 but**

before issue of the Govt. OM ibid will be as per the provisions contained in para 2.2 of this circular.

- 2.2 Old Data Sheet (Appendix-'A'), new Data Sheet (Appendix-'I') and form of option, are enclosed to this circular for the purpose of notification of pensionary awards based on revised scale of pay in respect of category of Govt. servants as mentioned in para- 2.1 ante.
- 2.3 The purpose for filling up of two Data Sheets for one case is to determine the additional amount of pension for commutation due to modification of commutation table w.e.f date of issue of the ibid Govt. OM. However, a single PPO will be issued in such cases.
- 2.4 A copy of this circular may be transmitted to all units/formations declared as "Head of Office" under intimation to us.
