In modification of the instructions contained in para 1 of this Department's OM of even number dated 19th May, 2008, it has been decided, that all proposals for deputation / foreign service of officers of the level of JS and above may be forwarded to this Department with 10 copies of the note alongwith relevant papers as in the format annexed, for being placed before the Screening Committee under the Chairmanship of the Cabinet Secretary.

- 2. It is also suggested that the same format may be used by the cadre controlling authorities for placing the matter before the Screening Committee in respect of officers of the level below JS.

Rule Position

According to para 2.1 of consolidated guidelines vide OM No. AB.14017/2/07-Estt.(RR) dated 29.02.2008 regarding deputation / foreign service for Members of the organized Group A and Group B Services of the Central Government (other than All India Services), a Committee under the chairmanship of Cabinet Secretary with Secretary (Personnel), Finance Secretary will screen all proposals for deputation on foreign service terms of officers of the level of JS and above on a case to case basis, after the proposals have been approved by the Cadre Controlling Authority. The final decision shall be with the approval of the Prime Minister in such cases.

The proposal is being submitted to the Screening Committee under the Chairmanship of the Cabinet Secretary for taking an appropriate decision in the matter.
