Subject: Payment of immediate relief amounting to Rs. 50,000/- (Rupees fifty thousand only) as an advance against payment of Ex-Gratia lumpsum compensation to legal heir/NOK of deceased/permanently disabled Casual Paid Labourers (CPLs) who died/sustained accidental injuries resulted into total/partial disability while on Govt. Bonafide duty in BRO.

Sir,

I am directed to convey the sanction of the President of India in partial modification to the provision of Govt of India Ministry of Shipping, Road Transport & Highways, Dept of RT&H, BRDB letter No. BRDB/04(224)/2006-GE-II dated 14 Jan 2009 as amended from time to time for payment of advance of Rs 50,000/- (Rupees fifty thousand only) as Immediate Relief out of Ex-Gratia Lumpsum Compensation to be paid to the NoK/Legal Heir of deceased /disabled CPLs who die in harness/sustained injury resulted into total/partial disablement while on Govt Bonafide.duty. Initially the said amount of advance of Immediate Relief will be paid out of CPLs Welfare Fund of Project concerned and recouped subsequently on obtaining formal sanction of Competent Authority for payment of final Ex-gratia lumpsum compensation.

- 2. All other contents of above referred BRDB letter will be remain unchanged.
- 3. The total amount of Ex-Gratia Lumpsum Compensation (including advance as above) will be debited/adjusted against the contingencies of respective job under which deceased CPLs was engaged in GREF/BRO service on the day of death.
- 4. This order will come into effect from the date of issue of this letter.

5. This issues with the concurrence of Ministry of Defence (Fin/BR) vide their ID No. 19(5)/BRS/2019 (877/BRS/2023) dated 25.10.2023.
