1. The following candidates have been shortlisted for the post of **UDC** SSC-CGLE 2025 on subject to qualifying in Physical Efficiency Test (PET), Documents Verification (DV) and Primary Medical Examination (PME)

2. The following candidates are hereby advised to report at **BN Gate, GREF Centre, Dighi Camp, Pune-15** on **22 July 2026 at 0830 hrs** alongwith following documents (original + 06 copies duly attested by Officer mentioned at Page No. 5 of Attestation Form):- (**Note: No documents in regional language will be accepted.**)

(a) **Attestation Form (Bilingual in Hindi and English)**. To be downloaded from BRO web site www.bro.gov.in. The candidate must ensure that Attestation Form is filled correctly in all respects. Some related guidelines for filling of Attestation Form are given below:-

(i) Photograph at Page No. 01 must be attested by an Officer as mentioned in Page No. 05 of Attestation Form duly enfacing with his name & designation stamp.

(ii) At specified location in page No. 06 of attestation form will be signed by Gazetted Officer of Central or State Government. The same officer will also attest the photograph affixed at page No. 01. The officer should know the candidate for minimum one year. The officer should sign the form duly mentioning identification period and enfacing his name & designation seal along with concerned **office seal/round seal (mandatory)**.

(b) **Proof of Residence**. Domicile certificate showing permanent residential address, issued by the competent authority. In case of Gorkha of Indian Domicile, Permanent Residence Certificate (PRC) to be issued by the competent authority.

(c) **Educational Qualification**. Original Mark sheet, certificate of 10th class, and the technical education qualification certification as required.

(d) **SC/ST/OBC/EWS Certificate**. Original Certificate of SC, ST, EWS and OBC as per specified format of Govt of India duly signed by competent authority with his name & designation stamp and **office round seal (mandatory)** affixed on the place provided. In respect of OBC candidates, the guidelines of Govt of India regarding creamy layer status be strictly followed. Latest **Format of Caste Certificate** can be downloaded from BRO web site www.bro.gov.in.

(e) **Proof of Marriage**. Candidates, who are married, are to produce marriage certificate issued by competent authority at the time of induction.

(f) **Claim in Respect of Age Relaxation**. As applicable as per SC/ST and OBC certificate.

(g) **Ex-Service Man Certificate**. A candidate who had applied under Ex-serviceman category should bring original certificate related to Ex-serviceman issued by competent authority.

(h) **No Objection Certificate**. If any individual has applied while serving with other department, he should bring original No Objection Certificate (NOC) issued by competent authority.

3. **Photographs**. 10 (ten) Nos recent colored passport size photos or that photographs which was affixed by you in application Form.

4. **Candidate is also required to bring following mandatory documents (for opening service documents, salary purposes etc):-**

(a) Joint A/c Bank Pass Book (preferably SBI), Cheque book and NEFT Mandate form.

(b) AADHAR Card, (c) PAN card

(d) NPS subscriber registration form (CRSF 1.5 Ver), downloaded from Central Record keeping Agency (CRA) - NSDL (www.cra.nsdl.com)

5. **Medical Examination**.

(a) You will have to undergo medical examination by the Medical Board of Officers from GREF/Armed Forces at GREF Centre, Dighi Camp, Pune-15. The physical standard and medical examination will be carried out as per the approved Standard Operating Procedure for recruitment in this department. Candidates declared permanent UNFIT by Board of Officers due to being below physical standards with respect to height, no appeal can be made against physical measurements. However, if you are found temporary/permanent unfit due to any other physical and medical reasons, you will have the right to appeal against the said medical examination within 60 days of declaring temporary/permanent unfit. You will have to report for medical review at GREF Centre, Pune 05 days in advance for medical review and same will be conducted at Military Hospital, Pune only.

(b) Medical examination may take approximate **one to two week time**. During this period you will have to make own arrangements for your stay and food. All expenditure towards your journey, lodging/boarding and food will be borne by you.

(c) You are to bring following medical investigation reports of yours from any Government/Government approved/CGHS/ECHS hospital or laboratory **(the medical investigation report should not be more than one (01) month old from the day of medical examination):-**

(d) **Also Ensure The Following Please:-**

- i) Your ear wax is cleaned so that your ear drum (TM) is clearly visible during ear examination.
- ii) Those who use glasses for vision should bring them as vision will be tested both with & without glasses.
- iii) In case you have undergone any major surgery, please bring the medical documents related to it.
- iv) If you are not a Sikh candidate, please come clean shaven.
- v) You have to come mentally prepared for examination of private parts (for males done by male doctor and for females done by female doctor) and ensure that they are clean and adequately shaved.
- vi) You are groomed properly and you come bathed so as to avoid inconvenience of body odor to others.
- vii) You meet the minimum height, weight and chest standards of your region so as to avoid wastage of money and time at your end.
- viii) Permanent body tattoos are only permitted on inner face of forearm and on the reverse side of palm/back (dorsal) side of hand (obscene, vulgar or objectionable tattoos are not permitted). Permanent body tattoos on any other part of the body is not acceptable and candidate will be barred from further screening.

8. **Training After Appointment.** If you are finally appointed, you will undergo training at GREF Centre, Dighi Camp, Pune-15 for a specified duration.

9. **Cancellation of Candidature.** If any candidate is absent on the date of reporting, his candidature shall be cancelled automatically. No representation/appeal in this regard will be entertained by the department.

10. **No Representation/Application.** No representation/application for change of date of Primary Medical Examination will be accepted/entertained.

11. **VARIATIONS/DISCREPANCIES IN DOCUMENTS.** For any variations/discrepancies found in education certificates, SC/ST/OBC/EWS certificate, domicile certificate, bank documents etc with respect of candidate's name and/or his father name and/or his mother name and/or his date of birth, the same to be corrected before reporting or an affidavit of first class magistrate to this effect be brought on reporting.

NOTE: IF ANY VARIATION/DISCREPANCY FOUND IN MARK SHEET/CERTIFICATE OF 10TH CLASS AND CANDIDATE NAME, FATHER NAME & DATE OF BIRTH OF THE CANDIDATE. THE SAME BE CORRECTED BEFORE REPORTING TO GREF CENTRE OR AN AFFIDAVIT OF FIRST CLASS MAGISTRATE TO THIS EFFECT MAY PLEASE BE BROUGHT ON REPORTING.
