Online bids are invited on single stage two bid system for **“SPECIAL REPAIR OF MONSOON DAMAGES OF REPAIR AND REHABILITATION OF 300 MTR SPAN CABLE SUSPENSION BYORUNG/GANDHI BRIDGE OVER SIANG RIVER LOCATED AT KM 2.908 ON YINGKIONG – MOYING ROAD (WORK TO BE KEPT UNDER SRMD WORKS AS PROVISIONED ON P-559 OF BRR) FOR THE FY 2025-26 UNDER 105 RCC SECTOR IN AOR OF 761 BRTF UNDER PROJECT OF BRAHMANK IN ARUNACHAL PRADESH : TENDER NO. Earnest money is not required to be attached with tender by the valid enlisted contractors with BRO in eligible class **i.e. Class B & above** who have submitted standing security deposit and MSME registered firms in relevant category who have experience in the similar works National Industry classification Code(S) as per Rule 170 (i) of GFR 2017 but it is required from other contractors to be attached (Scanned copy) with Technical Bid for **Rs 2,73,700.00 (Rupees Two Lakh Seventy Three Thousand Seven Hundred Only)** in the shape of Call Deposit Receipt/Term Deposit Receipt/Special Term Deposit Receipt/bank guarantee bond in favour of **CHIEF ENGINEER PROJECT BRAHMANK, C/O 99 APO** obtained from any Nationalized/ Scheduled Bank and having maturity/validity period 90 days more than validity period of this offer.

22. In case of applications/bids submitted by un-enlisted contractors where scanned copies of Bid Security declarations were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of financial bid.

If the appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his technical bid. Any appeal received after **05 days** of such publication of such result shall not be entertained under any circumstances.

Deptt. and work under other centrally sponsored schemes, for a period of one year from the bid due date of this work. In addition, related firms of L-1 tenderer revoking offer shall not be considered in tendering process for second or subsequent calls of subject work.


