Online bids are invited on single stage two bid system for **PROVIDING, LAYING, SPREADING AND COMPACTION OF GSB 100 MM IN TWO LAYERS, WMM 100 MM THICK, WMM 150 MM THICK, HOT MIX PLANT READY MIX OF BITUMEN VG-10/30, FOR DBM 55 MM THICK WITH PRIME COAT AND BC 40 MM THICK WITH TACK COAT INCLUDING SCARFYING EXISTING BT SURFACE AND PREPARATION OF SUBGRADE IN SMB, FOR SURFACING WORKS BETWEEN KM 0.00 TO KM 4.50 ON MOYING-YINGKIONG ROAD UNDER 105 RCC UNDER 761 BRTF OF PROJECT BRAHMANK IN ARUNACHAL PRADESH**

Bidders are advised to follow the instructions provided in the **'Instructions to the bidder for the e-submission of the bid online through the Defence Procurement Portal for e-Procurement at <https://defproc.gov.in/nicgep/app>** before proceeding ahead.

4. The work is estimated to cost **Rs 1390.69 Lakh (Rupees Thirteen Crore Ninety Lakh Sixty Nine Thousand Only)** approximately or as subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and DPP website <https://defproc.gov.in/nicgep/app> This estimate, however, is not a guarantee and is merely given as a rough guide and if works cost more or less, the tenderer shall have no claim on that account of whatsoever nature.

5. The tender shall be based on **General Conditions of Contracts IAFW-2249 and item rate contract form based on IAFW-1779 & amendments No. 41 to 48 to IAFW-2249** issued by Government of India, Ministry of Defence letter PC-I to 33487/IAFW-2249/R/858/2018/D (Works-II) (i) dated 14 January 2019, special conditions, particular specifications and drawings with schedule 'A' (list of works) to be priced by tenderers.

6. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstances will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

7. The work is to be completed within **15 months (Fifteen Months)** or subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and DPP website <https://defproc.gov.in/nicgep/app> on accordance with the phasing, if any, indicated in the tender

Earnest money is not required to be attached with tender by the valid enlisted contractors with BRO who have submitted standing security deposit and MSME registered firms as per Rule 170 (i) of GFR 2017 but it is required from other contractors to be attached (Scanned copy) with Technical Bid for for **Rs 10,21,000.00 (Rupees Ten Lakh Twenty One Thousand Only)** in the shape of Call Deposit Receipt/Term Deposit Receipt/Special Term Deposit Receipt/bank guarantee bond in favour of Chief Engineer Project BRAHMANK, C/O 99 APO obtained from any Nationalized/ Scheduled Bank and having maturity/validity period 90 days more than validity period of his offer.
11. Successful Bidder (L-1) shall deliver to Accepting Officer a Performance Security for an amount of 5% of contract sum in the shape of Bank Guarantee or FDR within 28 days of issue of LOA.

15. Any qualification documents/ tender which stipulates any alternative to any of the conditions laid down or which proposes any other conditions of any description whatsoever is liable to be rejected.

The Accepting Officer reserves his right to accept a tender submitted by a Public Undertaking, giving a purchase preference over other tender(s) which may be lower, as are admissible under the Govt policy. No claim for any compensation or otherwise shall be admissible from such tenderers whose tenders may be rejected on account of the said policy.

The submission of a tender by a tenderer implies that he had read this notice and conditions of contract and has made himself aware of the scope and specifications of the work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him, local conditions and other factors bearing on the execution of the work.

If the appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his technical bid. Any appeal received after **05 days** of such publication of such result shall not be entertained under any circumstances.

In the event of lowest tenderer revokes his offer or revise his rates upward (which will be treated as revocation of offer), after bid submission end date and before expiry of original validity period stipulated in tender documents, will be suspended for participation in the tendering process for the works of BRO/MoRT&H/NHAI/NHIDCL/Any other Govt. Deptt. and work under other centrally sponsored schemes, for a period of one year from the bid due date of this work. In addition, related firms of L-1 tenderer revoking offer shall not be issued the tender in second or subsequent calls of subject work.


