Online bids are invited on single stage two bid system for **"PROVIDING AND LAYING OF BITUMINOUS CONCRETE 30MM THICK INCLUDING CORRECTION WORKS WITH DBM 50MM AND ROAD MARKING WITH THERMOPLASTIC PAINTING FOR RESURFACING WORKS BETWEEN KM 97.000 AND 105.620 ON ROAD BASAR-BAME UNDER 92 RCC/44 BRTF IN PROJECT BRAHMANK IN THE STATE OF ARUNACHAL PRADESH" TENDER NO. 4. The work is estimated to cost Rs 414.45 Lakhs (Rupees Four Crore Fourteen Lakh and Forty Five Thousand Only) approximately or as subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and DPP website <https://defproc.gov.in/nicgep/app> This estimate, however, is not a guarantee and is merely given as a rough guide and if works cost more or less, the tenderer shall have no claim on that account of whatsoever nature.

5. The tender shall be based on **General Conditions of Contracts IAFW-2249** incorporating amendments including and upto 49 and **item rate contract form based on IAFW-1779**, special conditions, particular specifications and drawings with schedule 'A' (list of works) to be priced by tenderers.

6. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstances will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

7. The work is to be completed within **130 days** or subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and DPP website <https://defproc.gov.in/nicgep/app> on accordance with the phasing, if any, indicated in the tender from the date of handing over the site, which will be generally within one month from the date of issue of acceptance letter.

11. Successful Bidder (L-1) shall deliver to Accepting Officer a Performance Security for an amount of 5% of contract sum in the shape of Bank Guarantee or FDR within 28 days of issue of LOA.

If the appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his technical bid. Any appeal received after **05 days** of such publication of such result shall not be entertained under any circumstances.

In addition, L-1 tenderer revoking offer and his related firms shall not be allowed to participate in the tender in second or subsequent calls of subject work
