5. The tender shall be based on drawing, specifications, **General Condition of Contracts IAFW-1815 Z with schedule 'A'** (list of works) to be priced by tenderers.

6. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstances will a father or his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s) / director (s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

7. The work is to be completed within **330 days** or as subsequently amended in tender documents or uploaded in BRO website [www.bro.gov.in](http://www.bro.gov.in) and Defence e-procurement portal site <https://defproc.gov.in> website on accordance with the phasing, if any, indicated in the tender from the date of handing over of site as per work order No 1, which will be generally within one months from the date of issue of acceptance letter.

8. The **Chief Engineer, Project Deepak, Chakkar Barrier, Hari Nagar, Shimla (H.P.) PIN- 171005** will be the Accepting Officer, here in after, referred to as such for the purpose of this contract.

Original Copy of earnest money is required to be submitted within 05 days from bid submission end date. The receipt challan or any other means will not be considered against earnest money.

11. Successful bidder (L-1) shall deliver to Accepting Officer a Performance Security for an amount of **5%** of contract Sum in the shape of Bank Guarantee or fixed deposit receipt (FDR) within 28 days of issue of LoA.



If appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his Technical bid. Any appeal received after 05 days of such publication of result shall not be entertained under any circumstances.


