The work is estimated to cost Rs 147.37.00 Lakh (Rupees One Crore Forty Seven Lakh and Thirty Seven Thousand Only) approximately or as subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and DPP website <https://defproc.gov.in/nicgep/app> This estimate, however, is not a guarantee and is merely given as a rough guide and if works cost more or less, the tenderer shall have no claim on that account of whatsoever nature.

5. The tender shall be based on specifications, General Conditions of Contracts IAFW- 1815Z with schedule 'A' (list of works) to be priced by the tenderers

6. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstances will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

If the appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his technical bid. Any appeal received after **05 days** of such publication of such result shall not be entertained under any circumstances.
