Online bids are invited on single stage two bid system for **"SUPPLY AND STACKING OF CRUSHED STONE CHIPS OF SIZE 22.40 MM, STONE CHIPS OF SIZE 11.20 MM, STONE CHIPS OF SIZE 06.70 MM AND CRUSHED STONE DUST AT KM 9.00 (HMP SITE) ON BALIPARA-CHARDUAR-TAWANG (BCT) ROAD FOR THE RESURFACING WORKS (FY 2026-27) WITH 4.0 CM THICK BC AND 5.0 CM THICK DBM (CORRECTION WORK) BETWEEN KM 12.000 AND KM 14.800 ON BALIPARA-CHARDUAR-TAWANG AS PART "A" IN THE STATE OF ASSAM AND AS PART "B" FOR RESURFACING WORK BETWEEN KM 37.250 AND KM 69.550 ON BALIPARA-CHARDUAR-TAWANG ROAD IN THE STATE OF ARUNACHAL PRADESH UNDER 91 RCC/14 BRTF/(P) VARTAK"**

4. The work is estimated to cost **Rs 49.40 Lakh (Rupees Forty Nine Lakh Forty Thousand only)** approximately or as subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and **Defence eProcurement Portal website** : <https://defproc.gov.in/nicgep/app>. This estimate, however, is not a guarantee and is merely given as a rough guide and if works cost more or less, the tenderer shall have no claim on that account of what so ever nature.
5. The tender shall be based on **General Conditions of Contracts I.A.F.W.- 1815Z** including amendment and errata up to date as mentioned in tender document.
6. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
7. The work is to be completed within **180 days for 100% work** or as subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and **Defence eProcurement Portal website** : <https://defproc.gov.in/nicgep/app> website on accordance with the phasing, if any, indicated in the tender from the date of handing over the site, which will be generally within one month from the date of issue of acceptance letter.
8. **The Commander 14 Border Roads Task Force, C/O 99 APO will be the Accepting Officer**, here in after, referred to as such for the purpose of this contract.

Earnest money is not required to be attached with tender by the valid enlisted contractors with BRO who have submitted standing security deposit and MSME registered firm as per Rule 170 (i) of GFR 2017 but it is required from other contractors and to be attached (Scanned copy) with Technical Bid for **Rs. 98,800/- (Rupees Ninety Eight Thousand Eight Hundred Seventy only)** payable at SBI Tenga Valley, Arunachal Pradesh (Code No. 003594) in the shape of Call Deposit Receipt/ Term Deposit Receipt/ Special Term Deposit Receipt in favour of Commander 14 BRTF, C/O 99 APO obtained from any Nationalised/Scheduled BANK and having maturity/validity period 45 days more than Bid validity period.
11. Successful Bidder (L-1) shall deliver to Accepting Officer a Performance Security for an amount of 5% of contract sum in the shape of Bank Guarantee or FDR within 28 days of issue of LoA.

15. Any qualification documents/ tender which stipulates any alternative to any of the conditions laid down or which proposes any other conditions of any description whatsoever is liable to be rejected.

16. The Accepting Officer reserves his right to accept a tender submitted by a Public Undertaking, giving a purchase preference over other tender(s) which may be lower, as are admissible under the Govt policy. No claim for any compensation or otherwise shall be admissible from such tenderers whose tenders may be rejected on account of the said policy.

17. The submission of a tender by a tenderer implies that he has read this notice and conditions of contract and has made himself aware of the scope and specifications of the work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him, local conditions and other factors bearing on the execution of the work.

18. The Pre-Contract Integrity Pact has been signed by Accepting Officer or by the Officer specifically designated by him and scanned copy uploaded as part of NIT along with tender documents. Scanned copy of Integrity Pact duly signed on each pages by the bidder(s) shall be uploaded as part of technical bid (Cover-I) and original Integrity Pact duly signed on each pages shall be forwarded by post along with EMD.

The scanned copy of original instruments in respect of earnest money, Integrity Pact duly signed on each page by the bidder(s), and under taking regarding acceptance of tender conditions, Enlistment letter if firm is enlisted in BRO, EPFO, Registration letter, GST Registration and any other documents required to be submitted with respect to various conditions mentioned in the tender documents must be uploaded along with the technical bid. The Hard copies of all the documents should reach the tender Inviting Authority in the sealed envelope within **05 days** of bid submission end date.

21. Tender will be accepted as a whole. The bidder will not have any claim on this account and the decision of Accepting Officer shall be final and binding.

22. In case of applications/bid (enlisted contractor/as well as unenlisted contractors) where scanned copies of requisite Earnest money (as applicable) were uploaded but the same are not received in physical from within stipulated time, such bids shall not qualify for opening of finance bid.

In case of rejection of technical bid, contractor may appeal to next higher Engineering Authority i.e. HQ CE(P) Vartak on email bro-vtk@nic.in with copy to the Accepting officer on email bro-14brtf@nic.in against rejection within 05 days from the date of publishing of result of Technical qualification on **Defence eProcurement Portal website** whose decision shall be final and binding. If the appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his technical bid. Any appeal received after 05 days of such publication of result shall not be entertained under any circumstances. However, contractor/bidder shall not be entitled for any compensation whatsoever on account of rejection of technical bid.
