5. The tender shall be based on specifications, **General Conditions of Contracts IAFW- 1815 (Z) with schedule 'A'** (list of works) to be priced by the tenderers.

6. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

7. The work is to be completed within **180 days** or as subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and Defence eProcurement Portal site <https://defproc.gov.in> website on accordance with the phasing, if any, indicated in the tender from the date of handing over the site, which will be generally within one month from the date of issue of acceptance letter.

8. Commander 764 BRTF (GREF), **GSTIN 19CALH03714E1D0** for West Bengal and **GSTIN 11CALHO3714E1DG** for Sikkim will be the **Accepting Officer**, here in after, referred to as such for the purpose of this contract.

11. Successful Bidder (L-1) shall deliver to Accepting Officer a Performance Security for an amount of 5% of contract sum in the shape of Bank Guarantee or FDR within 28 days of issue of LoA.

The Accepting Officer reserves his right to accept a tender submitted by a Public Undertaking, giving a purchase preference over other tender(s) which may be lower, as are admissible under the Govt policy. No claim for any compensation or otherwise shall be admissible from such tenderers whose tenders may be rejected on account of the said policy.

17. The submission of a tender by a tenderer implies that he had read this notice and conditions of contract and has made himself aware of the scope and specifications of the work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him, local conditions and other factors bearing on the execution of the work.

20. Tenderer who has downloaded the tender from the BRO website shall not temper/modify the tender firm in any manner. In case if the same is found to be tempered/modify in any manner, tender will be summarily rejected and tenderer is liable to be banned from doing business with BRO.

21. The Accepting Officer does not bind himself to accept the lowest or any tender or to give any reason for doing so.

22. In case of applications/bids (submitted by un-enlisted contractors) where scanned copies of requisite bid security declaration were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

23. In case of rejection of technical bid, contractor may appeal to next higher Engineering Authority i.e., Chief Engineer (P) Swastik on email bro-swtk@nic.in with copy to Accepting Officer i.e., Commander 764 BRTF on email bro-764brtf@nic.in against rejection within 05 days from the date of publishing of result of technical bid qualification on the Defence eProcurement Portal whose decision shall be final and binding. If the appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his technical bid. Any appeal received after 05 days of such publication of result shall not be entertained under any circumstances.

The next Higher Engineer Authority shall preferably try to resolve the issue within 10 days of such representation. However, contractor/bidder shall not be entitled for any compensation whatsoever on account of rejection of technical bid.

24. A tenderer is deemed to have quoted rate for each item in schedule "A" including all taxes, SNT tax, GST as applicable as on date. Any increase or decrease in GST rate will be dealt as per CA condition. The bidder deemed to have full knowledge about the GST Act 2017 and relevant Rules and Regulations. It is compulsory for a tenderer to have GST registration before quoting the rates for this work.

In the event of lowest tenderer revoking his offer or revising his rates upward (which will be treated as revocation of offer), after opening of tenders, the performance security deposited by him shall be forfeited.
