Online bids are invited on single stage two bid system for **PROVIDING AND LAYING OF WMM 75 MM THICK (COMPACTED), WMM 100 MM THICK (COMPACTED), DBM OF 50 MM THICK (COMPACTED) AND BC OF 40 MM THICK (COMPACTED) INCLUDING APPLICATION OF PRIME COAT & TACK COAT WITH BITUMEN EMULSION, ROAD MARKING WITH THERMOPLASTIC PAINT (2.50 MM THICK) AND PROVIDING AND FIXING OF SOLAR STUDS FOR SURFACING WORK IN BETWEEN KM 8.000 AND KM 23.000 (JOB No. 24-LA-PWD-/2022) ON ROAD KHALTSE BATALIKOF 81 RCC/ 16 BRTF UNDER PROJECT VIJAYAK IN LADAKH (UT).**

The work is estimated to cost **Rs. 1316.00 Lakh (Rupees Thirteen Crore and Sixteen Lakh only)** approximately or as subsequently amended in tender documents or uploaded in BRO web site [www.bro.gov.in](http://www.bro.gov.in) and DPP website <https://defproc.gov.in>. This estimate, however is not a guarantee and is merely given as a rough guide only and if the work cost more or less, tenderer shall have no claim on that account of what so ever nature.

5. The tender shall be based on specifications, **General Conditions of contracts IAFW-2249** to be priced by the tenderers.

6. Not more than one tender shall be submitted by one contractor or contractors having business relationship. Under no circumstances will a father or his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

7. The work is to be completed within **365 days/12 months** as subsequently amended in tender documents or uploaded in BRO web site [www.bro.gov.in](http://www.bro.gov.in) and DPP website <https://defproc.gov.in> in accordance with the phasing, if any, indicated in the tender from the date of handing over the site, which will be generally within one month from the date of issue of acceptance letter. There will be three phases.



10. Earnest money is not required to be attached with tender by the enlisted contractor with BRO who have submitted standing security deposit but it is required from other contractors to be attached (Scanned copy) with tender documents for **Rs. 9,85,000.00 (Rupees Nine lakh & Eighty Five Thousand only)** in the shape of Call Deposit Receipt/Term Deposit Receipt/Special Term Deposit Receipt in favour of **Chief Engineer Project Vijayak, C/O 56 APO** obtained from any Nationalized/ Scheduled Bank having maturity/validity period 30 days more than validity period of his offer, payable at **SBI Kargil Code No. 1390 (J&K)**. Earnest money deposit of all unsuccessful tenderer will be returned immediately by endorsing an authority on the CDR for its refund. The earnest money deposit of the successful tenderer will be returned on receipt of the full security deposit or will retain it as a part of security deposit. Any other categories exempted for EMD by Govt policy like PSUs, MSME Vendors registered with NSIC in relevant field, UDYAM, Start up, KVIC, ACASH, WDO, Coir Board, Kendriya Bhandaretc are **exempted based on uploading of exemption certificate issued by competent authority in place of EMD**.

11. Successful Bidder (L-1) shall deliver to Accepting Officer a Performance Security for an amount of 5% of contract sum in the shape of Bank Guarantee or FDR within 28 days of issue of LoA.

The scanned copy of original instrument and ts in respect of EMD, duly signed on each page by the bidder(s), and under taking regarding acceptance of tender conditions, Enlistment letter if firm is enlisted in BRO, EPFO, Registration letter, GST Registration and any other documents required to be submitted with respect to various conditions mentioned in the tender documents must be uploaded alongwith the technical bid. The Hard copies of all the documents should reach the tender Inviting Authority in the sealed envelope within 05 days of bid submission end date.

20. Tenderer who has downloaded the tender from the BRO website shall not temper/modify the tender from in any manner. In case if the same is found to be tempered/modify in any manner, tender will be summarily rejected and tenderer is liable to be banned from doing business with BRO.

21. The accepting officer does not bind himself to accept the lowest or any tender or to give any reason for doing so.

22. In case of application/bids (Submitted by unenlisted Contractors) where scanned copies of requisite copy of instrument of EMD were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of financial bid.

If the appeal is not made within this period, the bidder shall forfeit his right of appeal against rejection of his Technical bid. Any appeal received after 05 days of such publication of result shall not be entertained under any circumstances.
